

CRB CHECKS INFORMATION SHEET



This fact-sheet has been produced by BVSC as part of Bexley's ChangeUp initiative which aims to improve the support to front-line voluntary and community groups. Local groups were asked to share information on where they obtained their criminal record checks to assist other groups.
