HOW WILL YOU WORK WITH OTHER GROUPS?

Gauge what the Must Haves and Would Likes of the funder are. Many funders like to groups compliment each others work rather than replicate it. <u>This funder</u> even states that not collaborating is a reason why funding is withheld. Collaboration can be efficient and put the beneficiaries needs before that of the charity making the application.

WAYS TO WORK WITH OTHERS

BASIC SAMPLE ANSWERS

Our group was formed when community groups and local people recognised the needs of young people on the estate, so from our very beginnings we have been collaborative. Research showed us that there was nothing else like our group, but that there were ways

that we could link with other groups.

Now our community youth group works with a local faith group so that we have access to a low cost large room for our youth centre. As this is on a busy estate our posters and their social media attracts people from the estate. Young people are signposted to our work from Social Services and through our work with Bexley Voluntary Services Council (BVSC) a number of voluntary and community groups signpost young people to us. We have had 11 speakers from different voluntary sector groups and the police visit the group in the last year. You can check them out on the Useful Links section of our website.

BVSC's Impact Officer noted how well we work with other groups in her feedback to us, saying: 'Your ability to work with others has strengthened your reach into the community and brings rich benefits to the young people you work with.'



WHO COULD YOU WORK WITH?

Any acronyms are spelt out the first time they are mentioned and the acronym written in brackets. After that the acronym can be used by itself.

Although the answer is mainly about how to work with others there is a hint here are the benefits of working together.

If you are not yet working with other groups then partnership work is encouraged increasingly by funders and you may want to consider this joined up approach. BVSC can help! Contact our Partnerships Officer.
